

READING ANNE OF GREEN GABLES TROUGH THE LENS OF POST-TRUTH CULTURE

Abstract

The post-truth culture is a circumstance when facts are less important than someone's preferences, or in other words, emotions and feelings are more important than the truth. The post-truth culture happens in all fields of life, including in the literature work. In this study, the writer chooses to analyze Anne of Green Gables, a novel written by a Canadian author, Lucy Maud Montgomery. This classic children's book tells a story about an eleven-year-old orphan girl named Anne Shirley, who was sent to middle-aged siblings, Marilla and Matthew Cuthbert, who had asked for a boy, not a girl, to help them on their farm. This paper aims to examine the real Lucy Maud Montgomery and a fictional Anne Shirley of Green Gables using the post-truth concept. The study found that Lucy Maud Montgomery is a Canadian author who gave a little touch of her real-life story in her novel. Four literary criticisms can be used to find the meaning and analysis of a literary text [2]: didactic approach, reflective approach, partisan approach, and religious approach. In this paper, the researcher used a reflective approach to analyzing literary work. A reflective approach is when literature can also contain some truths [2]. The author of the work use literature as a mirror to reflect the truth itself. In comparison with the didactic approach, the writer in the didactic approach is seen as a teacher, whether in a reflective approach, the author is an observer so that literature can provide some truth, but not all of it is something that we should take it as a lesson.

There is also educational evidence from journals examining Anne of Green Gables and post-truth analysis. The first evidence is a journal written by Arfiani [3]. Then, other evidence is research from Aneesh [1] Aneesh writes about how Petty Jenkins, through Diana in Wonder Woman movie, deals with the post-truth crisis.

This study is different from previous studies. The first study is Arfiani's discusses the similar personalities between Anne Shirley and LM Montgomery from

The readers can see the example from the story when Marilla introduces Anne to her friend, Mrs. Rachel Lynde, Anne does not like how Mrs. Lynde talks about her appearance, especially her red hair. Anne starts to shout at Mrs. Lynde and bring her

temper up. Mrs. Lynde is so horrified and does not like Anne Shirley. She asks Marilla to send her again to the orphanage. This situation also happens with other people who start to realize that Anne is very emotional and can not handle her feeling. Nevertheless, Marilla and Matthew try to teach Anne how to control herself rather than punish and send Anne back to the orphanage. Marilla and Matthew give the new perspective that having red hair is not why Anne is moody and emotional. It is because of her past experiences. Therefore, they are willing to teach and nurture Anne to help her control her emotion.

There are discrepancies between the situation in the fictional and real life. In her writing [6], Montgomery brought the idea that children have the right to get special care. In the eighteenth and early nineteenth century, orphans and poor children were regarded as cheap laborers. Poor children could not receive a formal education because they must pay for private education or only by the various churches. Therefore, Montgomery broke the tradition in that era that it was not common for the orphans and needy children to get specialized treatments, even education.

Anne's life journey fills with happiness and dreams but also great despair. She can make terrible mistakes but in the end. Marilla and Matthew Cuthbert always support and appreciate Anne for what she has done. For example, Anne always dreams about wearing a beautiful puffy sleeves dress like the other girls, and finally, Matthew Cuthbert buys it for Anne as a Christmas Gift. Marilla and Matthew also give support to Anne and her school's friend when they make a petition to stand up for Ms. Stacy, their new teacher, who uses a modern method to teach the students in Avonlea. Even though Anne

Shirley is a girl, it is not always easy for her to speak up because of the rigid society at that time, she has friends and the Cuthberts who always support her. Anne develops an excellent relationship with her society. The example is Anne get much appreciation from Mrs. Barry when Anne can handle Diana's sister, who get a cough with her traditional way until the doctor comes to Diana's house and help Ruby Gillis, her friend, out of her burning house. All of those appreciation increase Anne's confidence and give the courage to keep striving.

On the other side, Montgomery's childhood was not as pleasure as Anne's world. Maud's mother died when she was only 21 months old, and after that, her father left her with her mother's parents. As she grew up, little Maud became a very creative and strong girl. On the other hand, according to Montgomery, Lucy Maud's article [7], she also a moody and oversensitive girl. Her attitude became worst when she grew up. Because of that, Her grandparents suffered from her attitude. They try to control and limit Montgomery's actions. Sadly, the more her grandparents control herself, the more secluded Montgomery's life.

Maud childhood filled with so unwanted and unloved feeling. Moreover, her grandfather was very firm and had a sarcastic tongue. Young Montgomery should obey her grandparents' rules [3]. Even though Maud was a perfect and submissive girl, she never got any appreciation from her grandparents. Maud also has shown her passions for writing and storytelling from a very young age, but her relatives underestimated her abilities because they think it was not appropriate for a girl to do such things. Her family never honored her creativity and efforts.

Loneliness became part of Montgomery's life. Whenever she felt lonely, she will use her imagination and start to write something as the way out. Her family treatments caused her loneliness. Furthermore, Montgomery's grandfather did not want to accommodate her teacher's training course at Charlottetown [3]. Her grandfather's attitude towards her did not make shut off her spirit. On the contrary, she used it as a weapon to always strive to be better than before until she can make other people proud of her.

Montgomery's life mirror how society thought of women were more suitable to do some practical things. Instead of using her mind, it was better to sew to make the family clothes [6]. It was not what LM Montgomery wrote in her novel. She gave Anne the freedom to use her imaginations that was unusual in the nineteenth century.

In school, Anne is one of the smartest students in the class. Her dream is to be a teacher. On the other hand, there is a smart and popular boy named Gilbert Blythe, who then becomes Anne's rivals in school. On the first day of school, Gilbert wants to get Anne's attention by ridiculing her hair as a carrot. Anne gets angry and slaps his head with her slate, and she decided not to like Gilbert Blythe as long as her life. They become an enemy but also a friend. Destiny never goes wrong. As soon as they grow up, they become more mature and start to have feelings for each other. Both Anne and Gilbert do not realize their feeling until it is time for them to go to college. Comparing both Lucy Maud Montgomery's life with Anne's life is very interesting because Montgomery gave her childhood dreams in her writing.
